Bihar Rural Livelihoods Promotion Society (BRLPS), an autonomous society under Rural Development Department, Govt. of Bihar has been designated as State Rural Livelihoods Mission by Rural Development Department, Government of Bihar to scale up the "JEEViKA" model in all 534 Blocks of 38 Districts in Bihar under National Rural Livelihood Mission.

So far JEEViKA has been able to reach out to nearly 100 Lakh rural poor households by organizing them into 8.50 Lakh women Self Help Groups under 53000 Village Organizations and 890 Cluster Level Federations. These institutions have generated nearly **Rs. 833 Crore** as their own fund and have leveraged more than **Rs.7000 Crore** from the Banks.

Under NRLM, BRLPS would be organizing, empowering and promoting livelihoods for 1.2 crore rural poor households through 10 Lakh sustainable SHGs under 65000 Village Organisations and 1600 Cluster Level Federations.



3. Minimum Age limit is 18 years and maximum age limit is 60 years on the last date of receipt of online application for all the posts. Maximum age limit for retired officials from the government is 65 years.
 4. Candidates are requested to visit the website frequently for updates and other announcements.
 5. Reservation would be applicable for recruitment on these positions as per the latest Reservation Policy of the Government of Bihar. Only eligible candidates as per the required eligibility criteria will be called for participating in further stages of recruitment.
 6. BRLPS reserves the right to cancel this recruitment process, fully or partially, at any stage.
 7. Number of vacancies may be changed without prior notice.
 8. Only such Educational qualifications of the candidates would be considered as are approved by the AICTE/MHRD/respective states. PG Degree / Diploma of two years duration will only be considered.
 9. In case the Universities/Boards, award grades/CGPA/OGPA, the same will have to be indicated in equivalent percentage of marks as per the norms adopted by the respective University/ Board. In the absence of the same, the candidature will not be considered.
 10. BRLPS reserves the right to shortlist candidates based on qualification and post qualification relevant experience.
 11. Relevant experience is specific to the eligibility criteria and key responsibility as mentioned against each position.
 12. Shortlisting will be based on information provided by the candidates in the Application Form. No changes afterwards will be accepted in any circumstances.
 13. For the purpose of calculation of experience, the reference date will be the 1st April 2023.
 14. Post qualification relevant experience for the position will only be considered. Relevant Experience with Govt. Organization / Govt. Corporation / Govt. Authority/ Autonomous Govt. body / Registered Govt. Societies / Banks / PSUs and recognized International/ Multinational Organization may only be accepted. Experience of honorary position / as commission agent / Training / Internship / Articeship will not be accepted. Experience during the educational qualifications will also not be accepted. Recognized means recognized by State or the Central Government.
 15. The period of experience rendered by a candidate on part time basis, daily wages, visiting/ guest faculty will not be counted while calculating the valid experience.
 16. Article ship/apprenticeship/internship/training outside job or working in self owned enterprise will not be considered as experience.
 17. 1 year relaxation in experience will be allowed to a working employee of BRLPS who has completed at least 1 year of service with BRLPS, as per the provision of BRLPS HRD Manual.
 18. *Cost to Society (CTS) includes Basic Pay, House Rent Allowance, Project Allowance & Employees Provident Fund (Employers share).
 19. **Other monetary benefits allowed to BRLPS employees include Child Education Allowance for a maximum of two living children Annual Increment at the rate of 5%, Performance incentive up to maximum of 30% of Annual Basic as annual pay, Laptop Maintenance allowance, Self Learning Allowance, Accidental Insurance coverage, Medical Insurance cover for self & family, etc.
 20. Contract will be till attainment of the superannuation age of 60 for positions under BRLPS and one year for the positions under NRO that maybe extended further on the basis of performance and approval of the Competent Authority and continuance of the NRO Project. Employees may be separated if not found suitable at the discretion of the management. The contract would also end with the closure of the BRLPS project.
 21. Persons who had been separated from the BRLPS on disciplinary grounds need not apply as their candidature will not be considered.
 22. No TA/DA will be paid for attending different stages of selection process or first joining of BRLPS.
 23. There would be a probation period of 3/6 months.
 24. Record of the non-selected candidates shall not be preserved beyond 6 months from the date of preparation of the select list.
 25. Retired Officials from Govt., PSUs and Banks with enough zeal and willingness to work for the cause of the poor may also apply for the suitable positions. Retired government officials applying for various positions should have completed graduation to be considered for selection.
 26. Serving State Government Officials are encouraged to apply. Relevant deputation norms/BRLPS policy would be applicable to them.
 27. Retired Officials from Govt., PSUs and Banks /Serving State Government Officials for State Level positions of SPMs or equivalent must be in the grade pay of Rs. 5400/-or above as per the 6th Pay Commission norms.
 28. Remuneration for retired Officials from Government of Bihar will be fixed as per the provision of Sankalp No. 10000 dated 10/07/2015 and Letter No. 3/M-63/2013 Sa Pra 8710 dated 11/08/2021.
 29. Reservation facility would be applicable only to the Bihar domicile candidates. The permanent address furnished in the application form shall be considered as domicile for the purpose of reservation.
